## **DEPARTMENTAL ORDER: 02/2019**

Sub: Directions to all Adjudicating Authorities to put date below their signatures in Adjudication Orders- Reg.

Kind attention is invited to the CCO letter in F.No.C.No.IV/16/367/2015-16/CC(TZ)IV/B dated 20.05.2019 on the above subject enclosing the copy of the F.No.09/Adjudicating Authorities/CCU/2019 dated 23.04.2019 from Commissioner (AR) Admin, CESTAT, New Delhi on the above subject.

The Hon'ble Division Bench of CESTAT, New Delhi has observed that some Adjudicating Authorities are not putting dates below their signatures while issuing orders. The Hon'ble President, CESTAT remarked that the date of the despatch put up by the despatch clerk at the top of the Order or the date of endorsement of the Order to various noticees by A.C.(Adj) or Supdt (Adj) is not the date of issue of order. The actual date of issue of Order is the date below the signature of the Adjudicating Authority, which is missing sometimes.

All the Adjudicating Authorities are directed to keep in mind the observations of the Hon'ble Tribunal while passing Adjudication Orders.
