**ADMINISTRATION CIRCULAR NO. 12/2021**

**विषय Sub: Central Civil Services (Implementation of National Pension Scheme) Rules, 2021-Seeking options in the prescribed Form 1& 2 under the Rule 10 of CCS (Implementation of NPS) Rules, 2021-regarding.**

It is informed that Department of Pension and Pensioners' Welfare has issued Central Civil Services (Implementation of National Pension Scheme) Rules, 2021 vide G.S.R 227(E). dated 30.03.2021 regulating the service matters of Central Government employees covered under the National Pension Scheme system.

2. As per Rule 10(1) of CCS (implementation of NPS) Rules, 2021 Government servant, who are already in Government service and are covered by the National Pension System, shall exercise option for availing benefits under the National Pension System or under the Central Civil Service (Pension) Rules, 1972 or the Central Civil Service (Extraordinary Pension) Rules, 1939 in the event of his death or boarding out on account of disablement or retirement on invalidation as soon as possible after the notification of these rules. The Government servant shall along with the option in Form 1 also submit the details of family in Form 2 to the Head of Office.

3. It is therefore, requested that all officers / officials covered under NPS to furnish their option to the Assistant Commissioner of Customs (Administration) in the prescribed Form 1 & Form 2 (Copy enclosed) in triplicate latest by 10.07.2021, for record and onward submission to Central Record Keeping Agency.

This issues with the approval of the Commissioner.
