Sub: Sea Cargo Manifest and Transhipment (Second Amendment) Regulations, 2018 -Reg

Kind attention of importers, exporters, Steamer Agents, Consol Agents, Shipping Lines and all other stakeholders is drawn to the Public Notice No.34/2018 dated 15.10.2018 issued by this Office in respect of the Sea Cargo Manifest and Transhipment (Amendment) Regulations, 2018 and also to the Sea Cargo Manifest and Transhipment (Second Amendment) Regulations, 2018 notified by the Central Board of Indirect Taxes and Customs vide Notification No.88/2018 –Customs (N.T) dated 30.10.2018 (copy enclosed).

- 2. Consequent to the aforementioned amendment notified by the Board, the Sea Cargo Manifest and Transhipment Regulations, 2018 shall now come in to effect on 1st March 2019.
- 3. Authorised Carriers engaged in the filing of Arrival/Departure Manifests are therefore required to get themselves registered under the new Regulations before 1st March 2019.
- 4. All the stakeholders are required to take cognisance and comply with the new Regulations. Any difficulty in complying with the same may be intimated to the undersigned.

Notification No. 88/2018-Customs (N.T.)

New Delhi, the 30<sup>th</sup> October, 2018

G.S.R. (E). - In exercise of the powers conferred by section 157, read with sections 30, 30A, 41, 41A, 53, 54, 56, sub-section (3) of section 98 and sub-section (2) of section 158 of the Customs Act, 1962 (52 of 1962), the Central Board of Indirect Taxes and Customs hereby makes the following regulations further to amend the Sea Cargo Manifest and Transhipment Regulations, 2018, namely: -

- 1. Short title and commencement. (1) These regulations may be called the Sea Cargo Manifest and Transhipment (Second Amendment) Regulations, 2018.
  - (2) They shall come into force on the date of their publication in the Official Guzette.
- 2. In the Sea Cargo Manifest and Transhipment Regulations, 2018, in regulation 1, in sub-regulation (2), for the words, figures and letters "the 1st November, 2018", the words, figures and letters "the 1st March, 2019" shall be substituted.
