The dates for the four holidays of Idu'l Fitr (Ramzan) (June 05), Idu'l Zuha (Bakrid) (August 11), Muharram (September 09) and Milad-un-Nabi / Id-e-Milad [Birthday of Prophet Mohammed] (November 09) have been adopted from the State List. If the State Government changes any of these holidays, only the changed date will be observed as a holiday. If the change of dates, on any of the above occasions, is notified, at very short notice, through TV / AIR / Newspaper, by State Government, the same can be taken as authority for such change.

Republic Day, Independence Day and Mahatma Gandhi's birthday will be observed as Closed Holidays. Urgent work will be attended to on all other holidays and Saturdays (except on Sundays) between 10 am to 1 pm as usual with minimum staff.

There will not be any cash transactions in Custom House treasury on any holiday.
