Attention of all the eligible candidates appearing for the Written Examination under Regulation 6 of CBLR, 2018 is invited to the latest corrigendum to the Examination Notification issued by the Directorate General of Performance Management (DGPM), New Delhi and CBIC Instruction No.21/2018 -Customs dated 14.12.2018 on the forwarding of applications received for the said Examination to the National Academy of Customs, Indirect Taxes and Narcotics (NACIN).

- Vide the said Corrigendum, copy of which is enclosed as Annexure A, it 2. has been informed that the examination under Regulation 6 of CBLR, 2018, is proposed to be held in online mode and therefore the said Examination which was scheduled to be conducted on 18.01.2019 has been postponed till such time a date can be finalised for online examination.
- In this regard, Board has, vide Instruction No.21/2018 -Customs dated 3. 14.12.2018 (copy enclosed as Annexure B), has informed that the online examination shall be conducted by the National Academy of Customs, Indirect Taxes and Narcotics (NACIN) and has instructed this Office to forward the details of the eligible applicants to NACIN latest by 31.12.2018 in the format appended to the said Instruction.

In this regard, the <u>applicants whose applications have been accepted by the Commissioner of Customs (as notified by this Office vide Public Notice No.43/2018 dated 22.11.2018) are required to immediately furnish the <u>following additional details to this Office</u>, for onward submission to NACIN for the conduct of the examination in online mode:</u>
- (i) Personal Mobile Number of the applicant;
- (ii) Personal Mail ID of the applicant;
- (iii) Scanned soft copy of Passport sized photo submitted by the applicant in his/her application (in JPG/JPEG/PNG Format of size 20 to 60 KB)
- 5. The applicants shall mail the required additional details from their personal mail ID to the mail ID of the Import and Bonds Section of the Custom House (inbcoccus@gmail.com). The mail thus sent shall contain the following attachments:
- (i) A scanned copy of letter clearly mentioning the personal Mobile number and Mail ID of the applicant duly signed and endorsed by him/her;
- (ii) Scanned Passport sized Photograph of required specifications as mentioned in Para 4 above.

The receipt of the mails thus received shall be duly acknowledged by the Import and Bonds Section. The applicants are directed to ensure that their mails are acknowledged and contact the Section at +914842666772 or at +919746949370 for any queries in this regard.
