3. The processing of Bills of Entry filed before 17:00hrs on 1<sup>st</sup> February 2018 will also continue as usual. Further all concerned should keep track of Prior Bills of Entry filed before 1<sup>st</sup> February 2018 for any change of duty liability.
4. In terms of Section 4 of the Provisional Collection of the Taxes Act, 1931, the provisions of the Finance Bill will be effective from the midnight of 01.02.2018. In case where Prior Bill of Entry has been filed, the rate of duty levied in terms of Section 15(1)(C) of the Customs Act, 1962 is the date on which the inward entry of the vessel is permitted.

5. All the stake holders are advised to take note of the above to avoid inconvenience.
