Sub: Bank account details validation on ICES with Public Financial Management System (PFMS) for Drawback/IGST Refund claims - Reg.

Attention of all Exporters, Custom Brokers and other stake holders is invited to the subject cited above.

2. It is noticed that a large number of Drawback/IGST refund claims are pending for disbursement due to apparent mismatch of bank details between Public Financial Management System (PFMS) and the bank details provided by the exporter. Due to this mismatch, the accounts are not validated by PFMS and the PFMS status shown as "Response Awaited/Rejected". The Drawback/IGST Refund can be processed only if the bank details are validated by PFMS. The list of all such IECs with no. of shipping bills pending for Drawback/IGST Refund disbursement owing bank account validation, is attached herewith for information.

3. The exporter whose IEC code appears in the list enclosed is therefore directed to provide the following documents duly mentioning the latest bank details (**IFSC codes, Account Number, Name of the bank**) to this office at the earliest to resolve the issue and facilitate proper disbursement of the IGST refunds/drawback amounts.

- i) Request letter to Deputy Commissioner, Drawback/Statistics/EDI for registration.
- ii) Letter from Bank certifying the bank details
- iii) IEC copy
- iv) PAN copy


