Sub:- Disaster Recovery (DR) Drill planned from 21st to 23rd August 2020 - reg.

It is brought to the notice of all importers, exporters, Customs Brokers and other trade formations that Directorate General of Systems, Central Board of Indirect Taxes and Customs (CBIC) would be conducting a Disaster Recovery Drill from 20:00 Hours on 21st August 2020 to 12:00 Hours on 23rd August, 2020.

- 1. In this respect 22<sup>nd</sup> August 2020 will be a normal working day for ICES and all the functionalities will be available.
- 2. Document filing at Service Centers and through RES would be stopped at 20:00 Hours on 21st August 2020.
- 3. Work on ICES application at this location either by officers or by service center must be completed by 20:00 Hours on 21st August 2020.
- 4. ICES application is expected to be available again from 10:00 Hours to 19:00 Hours on 22<sup>nd</sup> August 2020 (Saturday).
- 5. Since 22/08/2020 would be a normal working day for our site, officers (covering complete workflow of ICES application) shall be present as normal on 22<sup>nd</sup> August 2020 from 10:00 Hours till 18:00 hours for carrying out transactions in ICES application.

6. Service Centre shall be operational on 22/08/2020 from 10:00 Hours to 18:00 Hrs.
