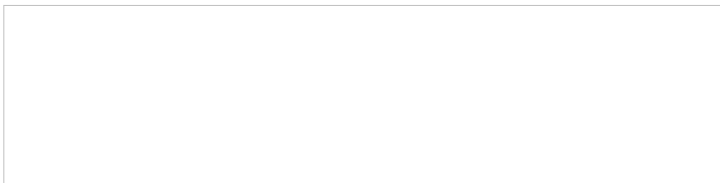
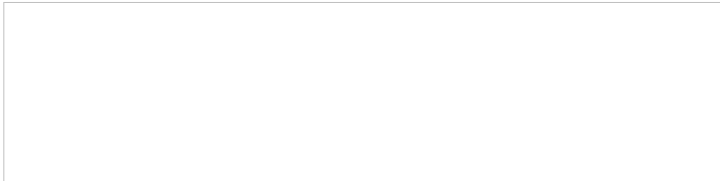

The National Academy of Customs, Indirect Taxes and Narcotics (NACIN), ZTA, Cochin, is in the process of drawing up a panel of willing and suitable candidates for filling up the following vacancies/ anticipated vacancies in the cadre of Administrative Officer/ Inspector/Executive Assistant/ Tax Assistant, as indicated below:

\* If any officer is found otherwise suitable for this office, the minimum prescribed eligibility can be reduced by the Competent Authority.

- The officer would normally be appointed for a period of 3 (three) years, which is extendable by 2 more years subject to satisfactory performance of the officer, his/ her willingness and concurrence from the concerned Cadre Controlling Authority.

4. The option once exercised will be final and in the event of selection, the officer will not be allowed to withdraw and they are expected to serve NACIN till the expiry of the full tenure of three years. Officers with less than three years of service remaining in the Department, are not eligible to apply.

5. In case while working in this Directorate, the conduct and/ or work performance of the officer is not found to be satisfactory, the officer shall be liable to be repatriated back to the parent Commissionerate/ Directorate without assigning any reasons.

6. The application, complete in all respects, may be forwarded to this office on or before 15/11/2021.
