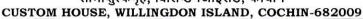

प्रशासनिक परिपत्र संख्या 02/2023 में आंशिक संसोधन के अनुसरण में, वितीय शक्तियों के प्रत्यायोजन नियम 1978 के नियम 13(3) के तहत अधोहस्ताक्षरी को व्यय विभाग एफ. संख्या 15/6/2008/आईएफय्-III दिनांक 15.09.2011 के साथ पढ़ा गया और राजस्व विभाग एफ. संख्या 30013/90/2006 विज्ञापन IV ए (पीटी-I) दिनांक 23.09.2011,के माध्यम से सूचित किए गए अनुसार प्रदत्त शक्तियों का प्रयोग करते हुए, मैं मौलिक नियमों और अनुपूरक नियमों/जीएफआर 2017 और वितीय शक्ति प्रत्यायोजन नियम, 1978 के विभिन्न प्रावधानों के पालन के अधीन विभाग के प्रमुख की निम्नलिखित शक्तियों का प्रयोग करते हुए एतद्द्वारा इस आयुक्तालय के अपर आयुक्त/संयुक्त आयुक्त (प्रशासन) और उप आयुक्त/सहायक आयुक्त (प्रशासन)/रासायनिक परीक्षक ग्रेड.
