Sub: Promotion of Havaldar to the Grade of Head Havaldar -reg.

Shri Suraj M S, Havaldar is promoted to the grade of Head Havaldar in Level 2 (Rs. 19,900 - Rs. 63,200) in the 7th CPC Pay Matrix (pre-revised Pay Band Rs. 5200-20200 with Grade Pay of Rs. 1,900) with effect from 01.01.2024 and until further orders:

2. Shri Suraj M S will be entitled for pay and allowances from the date of joining in the new grade. The officer is directed to join the post as Head Havaldar latest by **15.01.2024** failing which it will be construed that he is not interested in taking up the promotion. Failure to assume charge will be deemed as refusal to accept the promotion offered to him and action in terms of DOPT OM No. 22011/5/86-Estt.(D) dated 10.04.1989 (as amended) read with DP&AR OM No. 22034/3/81-Estt (D) dated 01.10.1981 shall be initiated.

3. The promoted officer should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Head Havaldar . Option once exercised will be final.

4. This order is subject to the final outcome of the order of the Hon'ble Supreme Court of India in the case of SLP No. 30621/2011 (Jarnail Singh and
