
Sub: Promotion of Inspectors (Preventive Officers) to the grade of Superintendent of Customs (Preventive)-reg.

The following officers in the grade of Inspector (Preventive Officer) are promoted to the grade of Superintendent of Customs (Preventive) in Level 8 (Rs. 47600/- - Rs.151100/-) in the 7th CPC Pay Matrix (pre-revised Pay Band Rs. 9300-34800 with Grade Pay of Rs.4,800/-) with immediate effect or from the date of assumption of charge in the promoted grade and until further orders:

2. They will be entitled for pay and allowances in the next grade of promotion from the date of assumption of charge in the new grade. The above mentioned individuals must assume charge as Superintendent of Customs (Preventive) latest by **26.08.2021** failing which it will be construed that they are not interested in taking up the promotion. Failure to assume charge will be deemed as refusal to accept the promotion offered to them and action in terms of DOPT OM No. 22011/5/86-Estt.(D) dated 10.04.1989 (as amended) read with DP&AR OM No. 22034/3/81-Estt (D) dated 01.10.1981 shall be initiated.

3. This order is subject to the final outcome of (i) OA No. 899/2019 filed by Smt. Rakhee Krishnakumar & Ors. before the Hon'ble CAT Ernakulam Bench, and (ii) the final outcome of the order of the Hon'ble Supreme Court of India in the case of SLP No. 30621/2011 (Jarnail Singh and others vs. Lachhmi Narain Gupta and others).
