- 2. They will be entitled for pay and allowances in the next grade of promotion from the date of assumption of charge in the new grade. The above mentioned officers must assume charge as Superintendent of Customs (Preventive) latest by 15.01.2020 failing which it will be construed that they are not interested in taking up the promotion. Failure to assume charge will be deemed as refusal to accept the promotion offered to them and action in terms of DOPT OM No. 22011/5/86-Estt.(D) dated 10.04.1989 (as amended) read with DP&AR OM No. 22034/3/81-Estt (D) dated 01.10.1981 shall be initiated.
