Failure to assume charge will be deemed as refusal to accept the promotion offered to them and action in terms of DOPT OM No. 22011/5/86-Estt.(D) dated 10.04.1989 (as amended) read with DP&AR OM No. 22034/3/81-Estt (D) dated 01.10.1981 shall be initiated.

- 3.** The promoted officers should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Tax Assistant. Option once exercised will be final.
