Central Bureau of Investigation, being a predominantly deputationist organization, needs services of officers of other police organizations on deputation. Inspectors are cutting-edge level officers in CBI, being entrusted with investigation of complex cases. They also form part of investigating teams to investigate complex and complicated cases.

Deputation of officers from other organizations in CBI certainly helps the Bureau but also enriches deputationists and widens their horizons, thus benefiting both the lending and borrowing Organisations.

As per prevailing Recruitment Rules for the post of Inspectors of Police in CBI, the eligibility conditions are as follows:-

- Graduate from a recognized university;
- Officers of Central or State Police Forces or Armed Forces holding analogous posts on regular basis in the parent cadre or department or with five years regular service in the grade of Sub-Inspector of Police;
- Inspector of Railway Protection Force or Inspector of Central Excise and Customs or Preventive Officers Grade-I or Examiner in Customs Office or Income Tax Inspectors or persons working in the analogous post in the Pay Level-8 on regular basis under the Central Government or State Government or Central Public Sector Undertaking with at least five years' Executive experience in vigilance or investigation or intelligence work in organizations mentioned at (iii) above.

The officers on deputation to CBI are entitled for Special Incentive Allowance of 20% of basic pay every month and also 13 months' salary as applicable from time


