Subject: Furnishing of the Annual Immovable Property Returns for the year 2018 (as on 01.01.2019)-Reg.

\*\*\*\*\*\*

All the staff members of this Custom House are directed to furnish their Annual Immovable Property Returns (IPRs) for the year 2018 (as on 01.01.2019) on or before 31 January 2019 in the prescribed pro-forma available at the website of Cochin Customs – http://www.cochincustoms.gov.in/default.php/forms.

- 2. All the staff members of this Custom House are directed to give the full particulars regarding the immovable property inherited by him or owned or acquired by him or held by him on lease or mortgage either in his own name or in the name of any member of his family or in the name of any other person. The details of prior intimation/permission given in this regard may be annexed to the property return. The Immovable Property Returns that are incomplete or deficient in any of the requisite details will not be taken on record and it will be deemed that the concerned staff member has not furnished their Immovable Property Return for this year.
- 3. As per extant instructions on the subject, non-submission of IPR within the stipulated date would invite the denial of Vigilance clearance for

empanelment, deputation and applying to sensitive posts and assignment to training programme (except mandatory training) as the IPR status needs to be checked for the said purposes.

- 4. Non-Compliance of these instructions will be viewed seriously and suitable action will be initiated against the defaulters. It is also to be noted that every APAR form contains a column wherein the officer concerned is required to indicate whether the IPR was submitted in time and any false information furnished in this regard will be considered as misconduct.
