Subject: Maintenance of punctuality in attendance by officers at all levels.

Whereas the Department of Personnel & Training (DoP&T) had vide Office Memoranda No. 13/4/85-JCA dated 21.05.1985 and No. 13/11/86-JCA dated 07.11.1986 stipulated that administrative offices of Central Government Offices outside New Delhi shall observe an eight hours working day, (inclusive of an obligatory half an hour lunch break), with a total of forty hours per week.

- 2. Whereas in the light of the above instructions, it is reiterated that the working hours of all the administrative offices within the jurisdiction of this Custom House shall be from 09.00 AM to 05.30 PM. All officers shall strictly comply with the same. There shall be a lunch break of half an hour between 1.00 PM and 1.30 PM.
- 3. It is reminded that punctuality in attendance being an essential attribute of discipline and discipline being a basic norm of administration, no laxity in this regard can be allowed. Officers at all levels are therefore cautioned against late arrival and early departure from office. Officers are also warned that by virtue of FR 17-A, unauthorised absence from duty shall be deemed an interruption or break in service of the employee.

- 4. Belated attendance, early departures and unauthorised absence shall be deemed as conduct unbecoming of a Government servant, which is reflective of deficiency in devotion to duty. Instances of such conduct, if noticed, would be strictly dealt with and officers practising such conduct shall be liable to be proceeded against under the provisions of the Central Civil Services (Classification, Control and Appeal) Rules, 1965.
- 5. Section heads shall conduct period checks in this regard and non-compliance with these instructions shall be forthwith reported. Vigilance unit shall also conduct surprise checks in this regard.
