#### **COVERAGE/ELIGIBILITY**

## **ELIGIBILITY / BENEFITS**

Sr. No	Occurrences	Amount of Ex-gratia financial assistance
А	Death attributable to performance of enforcement functions	Rs. 25 lakhs
В	Death attributable to accidents or incidents of violence while on duty	Rs. 15 lakhs
С	Death attributable to corona virus disease (COVID-19) contracted while on duty	Rs. 7 lakhs*
D	Death not covered under A, B or C above	Rs. 5 lakhs
Е	Permanent injury or disability sustained in performance of official duty	Rs. 15 lakhs

\*Rs. 5.0 lakh is admissible for Deaths attributable to corona virus disease (COVID-19) contracted while on duty between of 13.04.2020 & 20.08.2020.
