At the time of document verification, candidates are required to produce the following documents (in original) along with 3 sets of photocopy for verification:

- Matriculation / High School Certificate showing Date of Birth.
- Academic Certificates in support of Educational Qualification.
- Caste / NCL Certificate in case of SC/ST/OBC.
- Certificate in case of Person with disabilities (Divyangjan) candidate.
- Character Certificate from two Gazetted officers of the Central or State Government or Stipendiary Magistrates.

e) Discharge Certificate/No Objection Certificate from previous/current employer in case the candidate is employed in any of the offices under the Central Government/State Government, Autonomous Body, and Public Sector Undertaking presently. The certificate should be obtained with reference to this Notice.

f) Aadhar card.

g) The attestation form, in triplicate, may be duly filled (by hand only) and produced at the time of document verification. Candidates must affix latest clear photograph as prescribed in the attestation form.

4. Candidates are required to make your own arrangements for stay. The Department will not pay any travelling or other expenses to the candidates at the time of Medical Test and Document Verification.
