अध्यक्ष महोदय ने सदस्यों का स्वागत किया The Chair welcomed the members to the meeting.

विचार विमर्श के लिए नए मुद्दे FRESH POINTS FOR DISCUSSION

मुद्दा सं. 1. कंटेनर की आवाजाही की अनुमति की प्रक्रिया में संशोधन Point No. 1 Modification in procedures of Container Movement Permission

CSAA stated that presently, upon filing of continuity bond with customs, our steamer agents are required to take permission for each and every container for moving out of the terminal. CSAA further requested that this can be further simplified by issuing an order similar to PN 82/2018, NV-IV, JNCH dated 16.05.2018. They requested that a similar Public Notice may be issued in this Custom House as well.

The Chair stated that the Nhava Sheva Public Notice will be studied and if possible, similar orders would be issued in respect of this Custom House.

कार्रवाई सहायक आयुक्त (निवारक) Action : Assistant Commissioner (Prev.)

मुद्दा सं॰ 2 बी-17 बॉन्ड को स्वीकार न करना और कार्य के लिए अलग बॉन्ड Point No. 2 B-17 Bond not being accepted & Separate Bond for jobbing

Shri N N Menon, EPCES stated that vide Customs Circular 29/2017 dated 17.07.2017 has clearly stated that B-17 being a general purpose bond serves the requirement of continuity bond and therefore EOUs are not required to submit separate continuity bond. Shri Menon further stated that the same system may be continued

The Chair stated that it has not been brought to his notice of any specific case where B-17 Bond has not been accepted. He asked Shri Menon to bring any specific case to his notice, if required.

मुद्दा सं. 3 फ़ाईलों का हस्तांतरण Point No. 3 Transfer of files.

Shri Menon, EPCES stated that the files from the erstwhile jurisdictional Office has not yet been transferred to this Custom House which debilitates the Officers in Custom House to process import clearance.

The Chair stated that action has been taken to ensure that files from erstwhile jurisdictional office are transferred to Custom House.

मुद्दा सं. 4 सीमाशुल्क ब्रोकरों द्वारा आयात/ निर्यात से संबन्धित दस्तावेजों को 5 वर्ष तक रखना।

Point No. 4 Keeping of documents of imports/exports for a period of 5 years by Customs Brokers

CCBA stated that as per Trade Facility Notice 14/2018, importer/broker has to retain all original documents for a Bill of Entry for a period of 5 years from date of presentation, either in digital format or otherwise which the CB used for filing the integrated declaration. CB further added that Custom House was charging DMS fee for digital storage of these documents and that with E-sanchit all documents being uploaded digitally. CB requested that maintaining large documents would be quite difficult.

The Chair stated that Trade Facility Notice No. 14/2018 was issued to communicate the Bill of Entry (Electronic Integrated Declaration and Paperless Processing) Regulations, 2018 and this was mandated by CBEC and the Customs Brokers shall comply with the same.

मुद्दा सं. 5. ई ओ यू को निर्यात कंटेनरों की 100% परीक्षा

Point No 5. 100% Examination of containers of imports to EOUs

CCBA stated that new examiners are insisting the import containers of EOU undergoing 100% examination.

The Chair stated that this is a vague statement and requested that specific details may be provided.

मुद्दा सं. 6. ईजीएम में गलती होने के मामले में संशोधन शुल्क में छट के लिए अनुरोध। Point No. 6 Request for Waiver of amendment fees for EGM Error Cases.

CCBA requested for a waiver of amendment fees for EGM Error cases.

The Chair stated that amendment fees are collected as per statute and there is no scope for waiver of amendment fee.

Since no other points came up for discussion, the Chair declared the meeting with a word of thanks to the members.
