विषय: कार्मिक एवं प्रशिक्षण विभाग के का.ज्ञा सं. 35014/2/ 80-एस्ट (डी) दि. 07.02.1986 और 220011/7/86- एस्ट (डी) दि. 03.07.1986 के प्रावधानों को माननीय सर्वोच्च न्यायालय द्वारा वर्ष 2008 के CA No. 7514-7515 एन आर परमार और अन्य बनाम भारतीय यूनियन और अन्य के मामले में दिनांक 27.11.2012 को दिये गए निर्णय में की गई व्याख्या के अनुसार निरीक्षक (निवारक अधिकारियों) के मसौदा वरीयता सूची का प्रकाशन -संबन्धित।

Sub: Publication of Draft Seniority List of Inspector (Preventive Officers) in accordance with the provisions of DOPT OM Nos. 35014/2/80-Estt(D) dated 07.02.1986 dated 07.02.1986 and 220011/7/86-Estt(D) dated 03.07.1986 as interpreted by Hon'ble Supreme Court of India in the Judgement dated 27.11.2012 in CA No. 7514-7515 of 2008 in the case of NR Parmar&Ors Vs UOI & Ors – Reg.

1. उपर्युक्त माननीय सर्वोच्च न्यायालय के आदेश और सीबीईसी के निर्देशों के अनुपालन में सी.सं. ए-32022/06/2014-एडी.IIIA दिनांक 08.09.2014 के अनुसार कार्मिक एवं प्रशिक्षण विभाग के का.ज्ञा सं. 35014/2/80-एस्टेट (डी) दिनांक 07.02.1986 जारी होने के बाद जारी किए गए सभी निरीक्षकों (परीक्षकों) के ग्रेड की वरीयता सूचियों की जांच की गई ताकि डीओपीटी के का.ज्ञा सं. 35014/2/80-एस्ट (डी) दिनांक 07.02.2016 और 220011/7/86-एस्टेट (डी) दिनांक 03.07.1986 में शामिल आंतरिक वरीयता के प्रावधानों के अनुरूप हो सके। इस तरह के पुनरीक्षण के लिए अपनाया गया मानदंड इस प्रकार है:

In compliance with the aforesaid Hon'ble Apex Court Order and CBEC's instructions issued vide C No. A-32022/06/2014-Ad.IIIA dated 08.09.2014 all the seniority lists in the grade of Inspector (Preventive Officers) published after issuance of DOPT OM No. 35014/2/80-Estt(D) dated 07.02.1986 have been revisited so as to conform to the provisions of inter-se seniority as contained in DOPT OM Nos 35014/2/80-Estt(D) dated 07.02.1986 and 220011/7/86-Estt(D) dated 03.07.1986. Criteria adopted for such revisiting is as under:

i) कर्मचारी चयन आयोग की परीक्षाओं के माध्यम से भर्ती निरीक्षक (निवारक अधिकारियों) के लिए, सीजीएल 2004 आदि जैसे परीक्षा के नाम पर उल्लिखित वर्ष को 07.02.1986 और 03.07.1986 के डीओपीटी के का.ज्ञा. के प्रावधानों के संदर्भ में उपलब्धता के वर्ष के रूप में लिया गया है। अधिकतर मामलों में एसएससी द्वारा परीक्षा आयोजित करने के लिए अधिसूचना के प्रकाशन के साथ ही इन अधिकारियों के चयन के लिए भर्ती प्रक्रिया शुरू हो जाती है। कुछ मामलों में, परीक्षा के आयोजन के लिए अधिसूचना परीक्षा के नाम में उल्लिखित वर्ष से पहले जारी की गई थी (उदाहरण के लिए नवंबर, 2003 में सीजीएलई 2004 के आयोजन के लिए अधिसूचना जारी की गई थी)। लेकिन, चूंकि परीक्षा का उद्देश्य परीक्षा के नाम में उल्लिखित वर्ष की रिक्तियों को भरने के इरादे से किया गया था, इसलिए उनकी वरीयता केवल उस वर्ष में ही तय की गई है।

For Inspector (Preventive Officers) recruited through SSC Exams, the year mentioned in the name of the Exam like CGLE 2004 etc has been taken as the year of availability in terms of the provisions of DOPT OM's dated 07.02.1986 and 03.07.1986 ibid. In most of the cases the recruitment process for selection of these Officers has been started in that year with the publication of notification for conduct of examination by SSC. In few cases, the notification for conduct of examination was issued prior to the year mentioned in Examination Name (eg. Notification for conduct of CGLE 2004 was issued in

November 2003). But since the Examination was intended to fill up the vacancies of the year which was mentioned in Examination Name, their seniority has been fixed in that year only.

ii) कर्मचारी चयन आयोग की परीक्षा, 1986 के माध्यम से चुने गए सीधी भर्ती अधिकारियों के लिए वरीयता दिनांक 07.02.1986 के डीओपीटी का जा के प्रावधानों के अनुसार तय की गयी है। ओ ए सं. 773/04 और 114/05 में दिये गए केन्द्रीय प्रशासनिक ट्राइब्यूनल के आदेशों के अनुसार, निरीक्षक (निवारक अधिकारियों) की वरीयता सूची को दिनांक 22.05.2007 के परिपत्र सं. 15/2007 के अनुसार वर्ष 1995-96 तक की अवधि तक संशोधित किया जा चुका है। इसलिए उसके बाद के संशोधन को ही मसौदा वरीयता सूची में शामिल किया गया है।

ii) For Direct Recruit Officers selected through SSC Examination of 1986 onwards, the seniority has been fixed in accordance with the provisions of DOPT OM dated 07.02.1986. In pursuance of Hon'ble CAT order in OA Nos. 773/04 and 114/05, the seniority list of Inspector (Preventive Officers) were revised upto the period of 1995-96 vide Establishment Circular No. 15/2007 dated 22.05.2007. Hence further revision only is included in the draft seniority list.

iii) अधिकारी जो अंतर आयुक्तालयीन स्थानांतरण के आधार पर शामिल हुए, जिस वर्ष उनके अंतर आयुक्तालयीन स्थानांतरण आदेश जारी किए गए थे, उनकी उपलब्धता के वर्ष के रूप में लिया गया है और प्रासंगिकता के अनुसार उस वर्ष के अन्य सीधी भर्ती और पदोन्नतों के साथ उनकी वरीयता तय की गई है।

iii) The Officers joined on Inter Commissionerate Transfer basis, the year in which their ICT orders were issued has been taken as the year of their availability and their seniority has been fixed along with other Direct Recruits and Promotees of that year as per relevant provisions.

iv) पदोन्नति के लिए उपलब्धता का वर्ष उस वर्ष के रूप में लिया गया है जिस वर्ष डीपीसी आयोजित किए गए थे और ग्रेड में नियमित आधार पर उनकी पदोन्नति से संबंधित आदेश जारी किए गए थे। अधिकतर वर्षों में उसी वर्ष डीपीसी आयोजित किए गए थे जिसमें संबंधित आदेश जारी किए गए। कुछ कुछ मामलों में संबंधित वित्तीय वर्ष के पहले दिन शामिल होने के लिए उम्मीदवारों को सक्षम करने हेतु विशेष वित्त वर्ष की रिक्तियों को भरने के लिए डीपीसी पहले ही आयोजित किए गए थे। चूंकि आदेश जारी किए जाने वाले वर्ष से संबंधित रिक्तियों की वरीयता को तदनुसार तय किया गया है।

iv) The year of availability for promotee is taken as the year in which DPCs were conducted and corresponding Orders were issued for their promotion to the Grade on regular basis. In most of the years, the DPCs were conducted in the same year in which the respective Orders were issued. In a few cases, DPCs to fill up promotee vacancies of particular financial year were held in advance to enable candidates to join on the first day of the relevant vacancy year. Since vacancies related to the year in which Order was issued, the seniority has been fixed accordingly.

v) खेलकूद कोटा पर नियुक्त अधिकारियों की वरीयता को दिनांक 04.08.1980 के डीओपीटी का जा सं. 14015/1/76-एस्ट (डी) के अनुसार तय किया गया है।

v) Seniority of Officers appointed on Sports Quota has been fixed in accordance with DOPT OM No. 14015/1/76-Estt.(D) dated 04.08.1980.

vi) अनुकंपा के आधार पर नियुक्त अधिकारियों की वरीयता डीओपीटी के का जा सं. 14014/6/1994-एस्ट (डी) दिनांक 09.10.1998 के अनुसार तय किया गया है और उसके बाद का संशोधन डीओपीटी के जा संख्या 20011/1/2008-एस्ट(डी) दिनांक 11.11.2010 के अनुसार किया गया है।

vi) Seniority of officers appointed on Compassionate Ground has been fixed in accordance with DOPT OM No. 14014/6/1994-Estt.(D) dated 09.10.1998 and subsequent amendment thereto effected vide DOPT OM No. 20011/1/2008-Estt.(D) dated 11.11.2010.

vii) रिक्ति वर्ष 2015-16 तक की वरीयता की समीक्षा की गई है।

vii) The seniority has been revisited up to the vacancy year 2015-16.

उपरोक्त आधार पर तैयार किए गए निरीक्षक (निवारक अधिकारी) की मसौदा वरीयता सूची को कोचीन सीमा शुल्क की वेबसाइट में अपलोड कर दिया गया है। इस संशोधन में किसी भी त्रुटि से बचने का प्रयास किया गया है। निरीक्षकों (निवारक अधिकारियों) के ग्रेड में वरीयता सूची का यह संशोधन उन अधिकारियों के लिए पूर्ववर्ती रूप से लागू होगा जिन्हें बाद में उच्च श्रेणी में पदोन्नत किया गया है।

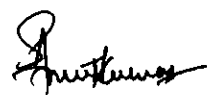
