1. The bidder must possess three years of work experience.

2...Bidder should have completed at least three (03) similar type of supply or order satisfactorily with state/central government organisation or under taking (List of such orders should be enclosed).

The bidder should be free from all encumbrances and there shall not be any vigilance case/CBI case/Court Case pending against him and also should not be black listed by any Govt./Semi. Govt./Private institution .

- 3. The vender must have a valid PAN No. and a valid Bank Account in any of the Nationalised Banks/Scheduled Banks (In case of Ltd./Pt. Ltd/Partnership Firm, the PAN and Account shall be in the name of the Firm/Company and in case of Individual Ownership, the PAN and Account may be in the name of Ownership.
- and Account may be in the name of Owner).
- 4. The Sealed Quotation shall be submitted "The Chemical Examiner, Gr-I, O/o The Commissioner of Customs, Customs House Laboratory, W.Island, Kochi-9", along with all the tender documents and the Tender Acceptance Letter duly signed in all the pages. The requirements for awarding tender are mentioned in Annexure-III. All the pages of the bid must be sequentially numbered and signed. Over writing, if any, has to be duly initialled by the bidder or his authorised signatory. In case of non-submission of copies of documents specified, such bids shall be summarily rejected. The offers submitted through any means other than in the tender document shall not be considered. No correspondence will be entertained in this matter. Bids without Earnest Money Deposit (EMD) or EMD exemption proof shall not be considered for Technical Evaluation and shall be rejected there itself (see para 6 of this notice).

Earnest Money Deposit (EMD)/Bid Security: Rs. 10,000/- (Rupees Ten Thousand Only) shall required to be furnished by way of DD/Banker's Cheque issued by Nationalized/Scheduled Bank only in favour of "The Commissioner of Customs, Customs House Cochin" payable at Cochin. The Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises or Startups as recognized by the Department of Industrial Policy and promotion (DIPP) are exempted from furnishing EMD. The hard copy of DD/Banker's Cheque in original OR for claiming exemption from EMD, hard copy of self-attested MoMSME certificate registered for manpower services, OR hard copy of self attested proof of being a start-up registered with DIPP should be attached with the tender document. 
## Annexure -IV (Details of work to be performed)


The Description of the work is as follows:-

1. The two new UPS (10 KV & 15KV) available in the Customs House Lab, should be given proper earthing (min. 2V) as per the fig attached herewith.

### Details for earth pitch:-

- a. Galvanised Steel or Copper cladding pipe with length of minimum 3M (10 feet) or up to reach Ground water table.
- b. Copper Plate in the bottom and two side copper strips to be given.
- c. For 10 feet need around 100 kg of Earth Chemical (Charcoal). Fill the earth chemical and sand, layer by layer alternatively.
- d. Diameter of the pipe: Min. 2 inch
- e. Thickness of the pipe:- Min. 3 mm
- f. Multi cored (8mm) ground cable
- g. 7 core earth wire from pitch to instrument and UPS o/p point.
  - 2. Provide additional 3 Phase wiring in AAS instrument room and provide 40amps & Single phase line for UPS, by providing proper input & output.
  - 3. Provide Cable Management/Trunking on two side wall of AAS room with 20 Nos of 15A plug points
