Sl. No.	Description of the Work
1	a) Making and fixing an SS (not less than 1mm thickness) Sign Board at the main entrance of the Residential Complex in Rectangular shape (17 ft length and 15" width) using 2" tubular GI pipes and painting it with one coat epoxy primer and two coat enamel paint with 6 ft height from the pillar of the gate and lettering it with CUSTOMS RESIDENTIAL QUARTERS, WILLINGTON ISLAND, COCHIN -682003 with enamel paint (colour as per instruction) b) Providing and fixing lighting fixture on top illuminating the sign board with adequate lighting.
2.	a) Replacing the damaged roofing sheet of the Guard room with new oranium roofing (approximately 55 Sq.ft) b) Replacing the damaged MDF panel with ACP panel (approximately 15 sheets of 2.43x 2.43 Mtr. size)

You are requested to inspect the site and submit your quote along with GST for the above work on or before 3.00pm on 10.03.2020 to the Commissioner of Customs, Cochin. The bids will be opened at 4.00 pm on 10.03.2020 at the chamber of Joint Commissioner. Interested bidders are welcome to take part. The debris and waste materials should be removed by the Party from the work site on completion of the work.
