

GENERAL TERMS AND CONDITIONS

1. EMD should be in the form of Bank Draft/Bank Guarantee in favour of Pay and Accounts Officer, Custom House, Cochin. Payable at Cochin.
2. Technical bids and financial bids are to be submitted through the e-procurement portal only. Any bids submitted through any other means will not be considered
3. The bidder should submit the details of GST registration, if not, should submit the declaration to the effect that they are not crossing the threshold limit of GST.
4. The successful bidder shall sign the contract within 15 days from the opening of financial bid.
5. The bidder should have active bank account with online transfer facility. Payment shall be made through PFMS mode only. Applicable tax, if any, shall be deducted at source.
6. The bidder should not have been blacklisted from business by any Central/State Govt. Department / PSU during last 3 years.
7. Legal jurisdiction for all disputes shall be within the purview of courts in Ernakulum.
8. This Tender may be terminated upon 30 (Thirty) days of written notice by the Commissioner of Customs, Custom House, Cochin-9 or by bidder.
9. The decision of the Competent Authority shall be the final to select the competent firms/bidders.
10. The government reserves the right to cancel the bid at any stage without specifying any reasons.
