

The Description of the work is as follows:-

Provide an extension (approx. 4 meters) to the existing LPG line

Specifications Required

½ inch High Quality SS Pipe shall be used with suitable weld joints if required and a control valve

Provide suitable bending union clamp with fittings

Provide 06 Nos of Bunsen Burners (full brass) with control valve and 'Suraksha ' hose

Provide a Main Valve Pressure Gauge

On completion, pressure and leak test should be carried out in presence of our officers and safety certificate from the competent authority has to be submitted.
