Sub: Uploading of Monthly Performance Report-reg

विषय : मासिक निष्पादन रिपोर्ट अपलोड करना -संबंधित।

सभी अनुभागों के प्रशासनिक प्रमुखों और अधिकारियों का ध्यान आकर्षित किया जाता है। यह पाया गया है कि मासिक निष्पादन रिपोटों में अपलोड किए जाने सांख्यिकीय आंकड़ों को नियमित रूप से और समय पर अद्यतन नहीं किया जाता है। जांच करने पर यह पाया गया कि अंतर-अनुभागीय रिपोटों को समयबद्ध रूप से नहीं भेजा जाना ही देरी का प्रमुख कारण है। यह भी पाया गया कि विभिन्न रिपोटों के समेकन के माध्यम और तरीके में भी स्पष्टता का अभाव है।

Attention is invited to Officers and Administrative heads of all sections. It is noticed that statistical data to be uploaded in Monthly Performance Reports are not being updated regularly and in time. On scrutiny it is noticed that the delay is primarily due to inter-sectional reports being not sent in a timely manner. It is also noticed that there is lack of clarity on the mode and method of compilation of various reports.

अधोहस्ताक्षरी ने एतद्द्वारा विभिन्न रिपोर्टों के समेकन और अपलोडिंग के लिए अनुभागों को नामित करने का निर्णय लिया है। मासिक निष्पादन रिपोर्टें संलग्न अनुबंध के अनुसार अपलोड की जानी हैं। अंतर- अनुभागीय रिपोर्टें हर महीने की 5वीं तारीख तक अग्रेषित की जानी हैं। विभिन्न अनुभागों से आंकड़े समेकित करने वाले अनुभागों को हर महीने की 10वीं तारीख से पहले रिपोर्टें अपलोड करनी चाहिए। रिपोर्टों को अपलोड करने में कोई भी मुश्किल हो, तो इसकी सूचना आयुक्त इकाई को दी जा सकती है।

The undersigned has hereby decided to nominate Sections for compilation and uploading of various reports. Monthly Performance Reports may be uploaded as per Annexure attached. Inter-sectional reports shall be forwarded by 5th of

every month. Sections which compile data from different sections shall upload the reports by 10th of every month. Any difficulty in uploading of reports may be informed to Commissioner's Unit.
